Spaces are available to rent at \$10.00 per 10 foot area, per day. If you pre-pay for Saturday and Sunday, Friday is free.

- \*\* Vendors will be allowed to enter the selling grounds during the times listed above.
- \*\* By purchasing your space, you agree to the terms and conditions as listed below.
- \*\* Vendors will be lined up and parked as you come in. If you want to be next to another vendor/flea marketer make sure you arrive with them as you pull into the parking lot.
- \*\* Items that contain profanity or obscenity will not be tolerated and will be removed. Items such as weapons including knives, guns, bows or anything else that may be deemed harmful or inappropriate will not be tolerated and will be removed.
- \*\* Participants are not permitted to sell anything that is not in their possession, stolen items, or that does not exist at the time.
- \*\* Participants are NOT permitted to sell food or drink of any kind. Participants doing such will be removed from the event.
- \*\* You must provide your own change. It is suggested you start your bank with miscellaneous coins and small bills.
- \*\* Participants are required to safeguard their own belongings. There must be someone attending a space at all times.
- \*\* You are responsible for cleanup of your area including garbage and unsold items upon your departure.
- \*\* Pop up tents are allowed on rented areas as long as they fit in the rented area and are properly anchored to the ground.

Vendor agrees to indemnify and hold harmless, Pocono Old-Tyme Farm Equipment Association and West End Fair Association and each and all of its subsidiary and affiliated corporations, companies and divisions, its predecessors, successors and assigns, and respective directors, stockholders, officers, employees and agents, harmless from any loss, damage, cost, expense, personal injury or claims which result from Vendors operations at the event. Specifically, Vendor agrees to indemnify POTFEA for any claims arising from Vendors use and operations on the Premises.
